Management Discussion and Analysis ("MD&A")

Set out below is a review of the activities, results of operations and financial condition of Rokmaster Resources Corp. (referred to herein together as the "Company" or "Rokmaster") for the nine months ended September 30, 2017. The following information should be read in conjunction with the Company's unaudited interim consolidated financial statements and the notes related thereto for the nine months ended September 30, 2017 and the Company's audited annual consolidated financial statements of Rokmaster and the notes related thereto for the year ended December 31, 2016.

This MD&A is prepared as of November 29, 2017 and all dollar amounts are stated in Canadian Dollars unless otherwise stated.

The Company is a reporting issuer in the Provinces of British Columbia, Alberta, Manitoba and Ontario in Canada. The Company's shares are listed on the TSX Venture Exchange in Canada under the symbol "RKR," on the OTC Pink Sheets in the USA under the symbol "RKMSF" and on the Frankfurt Stock Exchange under the symbol "1RR."

Business Overview and Overall Performance

Business Overview

The Company is primarily engaged in the acquisition, exploration and development of precious, base and industrial mineral properties. The Company's principal exploration areas of interest are North America, Central America and South America. The Company currently owns 100% of the Duncan Lake Zinc-Lead Property and has a 55% interest in the Big Copper property both located in the Slocan Mining Division in southeast British Columbia, Canada.

In order to achieve its objective, the Company has assembled a mineral exploration and management team with extensive experience in exploring, developing and bringing mines into production.

Overall Performance

Highlights of the Company's activities during the nine months period ended September 30, 2017:

- On September 28, 2017, the Company announced that it has acquired a 100% interest in 11 mineral claims totaling 620 hectares south of and adjacent to, its Duncan Lake Zinc Project.
- On August 23, 2017, the Company announced that it has received an enhanced Mines Act Permit from the British Columbia Ministry of Energy and Mines with respect to its Duncan Lake Zinc-Lead project. The Company also announced on this day that Mr. Antonio de Quadros has stepped down from the Company's board to accommodate the appointment of Mr. Moore.
- On August 14, 2017, the Company announced the appointment of Mr. David Moore to Rokmaster's board of directors as well as the granting of 600,000 stock options to a director.
- On May 3, 2017, the Company announced that Mr. Theodore (Ted) Muraro, P. Eng. joined the Company as a Special Advisor and Geological Consultant.
- On April 5, 2017, the Company closed the final tranche of its non-brokered private placement with the issuance of 6,017,000 units at a price of \$0.05 per unit for gross proceeds of \$300,850. The units from this tranche have the same terms as the ones that closed on December 28, 2016 except the warrants expire on April 5, 2019.
- On March 3, 2017, the Company completed its acquisition of a 100% interest in a certain British Columbia Mineral Tenure located in the Slocan Mining Division by issuing 250,000 Rokmaster common shares. The mineral claim adjoins the Duncan Lake Zinc Project.
- On January 30, 2017, the Company granted 7,950,000 incentive stock options to its directors, officers and consultants. The options are exercisable for a period of five years expiring on January 30, 2022 at an exercise price of \$0.06 per common share.
- On January 27, 2017, the Company completed its shares for debt transaction with various creditors by issuing 29,002,225 common shares at a deemed price of \$0.05 per share to settle outstanding debt in the aggregate of \$1,450,111 owed to directors, officers and certain arm's length creditors.
- On January 17, 2017, the Company completed its acquisition of a 100% interest in the Duncan Lake Zinc-Lead Property located in the Slocan Mining Division in southeast British Columbia, Canada approximately 64 km north of Kaslo, British Columbia pursuant to a property purchase agreement dated November 2, 2016 with John (Jack) Denny, Robert Denny and Graeme Haines. *Please see the Exploration Properties section of this MD&A and the Company's news release dated January 23, 2017 for further details.*

Exploration Properties

Duncan Lake Zinc-Lead Property, Canada

The Duncan Lake Zinc-Lead Property located in the Slocan Mining Division in southeast British Columbia, Canada (the "Property" or "Duncan Lake") approximately 64 km north of Kaslo, British Columbia. The Property consists of 35 contiguous mineral claims covering 3,929 hectares along the strike extension of Teck Resources Ltd.'s ("Teck") historical Duncan Mine property and 148 km by road northeast of Teck's smelter in Trail, British Columbia.

History of the Property

The Consolidated Mining and Smelting Company of Canada, Limited ("Cominco"), a predecessor of Teck, conducted four phases of exploration work on the Property from 1989 to 1997 included coring of 8,333.9 meters in 12 diamond drill holes. The work encountered significantly higher grade zinc-lead mineralization (see below Table of Selected Mineralized Drill Intersections) than was typically encountered at the Duncan Mine and confirmed that altered and mineralized carbonate strata extends from the Duncan Mine northward more than 2.3km and is open to the north, the west limb of Duncan Anticline and to depth on the Property. A further phase of drilling (8,800 meters in 8 holes) was recommended for 1998 but not conducted, possibly due to the steep decline in lead and zinc prices at the time and Teck's increasing involvement in Cominco which had begun in 1986.

A re-assessment of the current area covered by the Property north of the Duncan Mine by Cominco geologists indicated that an additional "900 meters of strike length of the structure has the potential to host 5 MMT ("Million Metric Tonnes") of 11.5% Zn and 1% Pb in No. 7 Zone and 2 MMT of 7% Zn and 0.3% Pb in the No. 8 Zone. If the known mineralization is projected 2,100 meters north (in the persistent plunge direction) to Jubilee Point, there is room for 16 MMT at 10% Zn." (D.W. Moore (1997): "Duncan

Mine Property: Proposal to Test Attractive Zinc Potential Close to Trail"). It was also noted that the 7^o northward plunge of the mineralized zone would be amendable to decline access and underground drilling as proven at the Duncan Mine. The potential quantity and grade stated above is conceptual in nature and there has been insufficient exploration to define a mineral resource. This represents a target for further exploration and it is uncertain if such further exploration will result in the target being delineated a mineral resource.

The scientific and technical information about the Property set out in this MD&A was obtained from a Technical Report for the Property dated December 13, 2016 and prepared for the Company, by R.A. (Bob) Lane, M.Sc., P. Geo. (the "Technical Report"). Mr. Lane advises that the geological data set out in the Technical Report was predominantly generated by Cominco during the 1989-1997 period and were recorded exploration assessment reports that were submitted to the British Columbia Ministry of Energy and Mines for property assessment credits. While Mr. Lane advises that he has made no attempt to verify the data, he states in the Technical Report that there is no reason to doubt its accuracy or veracity. Mr. Lane advises that he attempted to examine the drill core from 1989 to 1997 but advised that the observed racked or stacked core was quite disheveled. He stated that more than three-quarters of the core boxes could be recovered and re-racked and following that, the intact core could be verified. Mr. Lane advised that he collected some character core samples and had MS Analytical Laboratories in Langley, British Columbia, analyze the core. Mr. Lane advises that the historic drill data for the Property was adequate and that it provides a sound technical framework upon which future exploration programs could be built. Mr. Lane stated in the Technical Report that the level of QA/QC instituted by Cominco during its four phases of drilling was not known.

R.A. (Bob) Lane, M. Sc., P. Geo., a consulting geologist, is a Qualified Person as defined by National Instrument 43-101 *Standards of Disclosure for Mining Projects* and has reviewed and approved of the technical disclosure in this MD&A.

2017 Exploration Program – Duncan Lake Zinc-Lead Property

The Company has received an amended Mines Act Permit (the "Permit") from the British Columbia Ministry of Energy and Mines authorizing exploration activities including surface diamond drilling on a multi-year and multi-drill hole basis. The Permit expires in October 2022.

The Company commenced a preliminary program consisting of further data collection and compilation. This work includes recovery, re-organization and re-logging of selected historical drill core, analysis of selected core intervals for silver and gold and structural study to target initial drill holes.

The initial start date planned for drilling has been pushed to commence early 2018 to provide for the drill crew availability and contemplated financing.

Big Copper Property, Canada

The Big Copper Property ("Big Copper") is located in the Fort Steele and Slocan Mining Divisions, British Columbia, Canada and is approximately 45 kms by road west of Kimberly, British Columbia. The Company holds a 55% interest in Big Copper.

During the period ended December 31, 2012, the Company and its consultants conducted preliminary soil and silt geochemical surveys and prospecting along with evaluating all private and public data to select potential future exploration targets.

The Company conducted minimal exploration work on Big Copper during the year ended December 31, 2013 and no exploration work was done in fiscal years 2014, 2015 and 2016.

2017 Exploration Program - Big Copper

Results from that exploration work have been received and an assessment report, including recommendations for further work, has been completed and submitted.

Other than the assessment work required to maintain the claims, the Company has put exploration plans on Big Copper on standby pending improvements in the copper price.

Significant Accounting Policies

The Company prepares its unaudited condensed interim consolidated financial statements in accordance with International Accounting Standards 34, Interim Financial Reporting ("IAS 34"), using accounting policies consistent with International Financial Reporting Standards ("IFRS") as issued by the International Accounting Standards Board ("IASB").

The accounting policies and methods of application applied by the Company in these condensed interim consolidated financial statements are the same as those applied in the Company's most recent annual consolidated financial statements as at and for the year ended December 31, 2016, except for those policies which have changed as a result of the adoption of new and amended IFRS pronouncements effective January 1, 2017.

New, Amended and Future IFRS Pronouncements

More detail on these new, amended and future IFRS pronouncements are provided in Note 3 of the interim consolidated financial statements for the nine months ended September 30, 2017.

Critical Accounting Estimates and Judgments and Estimates

The preparation of financial statements requires management to use judgment in applying its accounting policies and estimates and assumptions about the future. Estimates and other judgments are continuously evaluated and are based on management's experience and other factors, including expectations about future events that are believed to be reasonable under the circumstances. There have been no significant changes to the Company's critical accounting estimates for the nine months ended September 30, 2017 from those disclosed in Note 4 of the audited consolidated financial statements for the year ended December 31, 2016.

The table below sets forth selected financial data, in Canadian dollars, relating to the Company for the years ended December 31, 2016, 2015 and 2014:

The Company is in the exploration stage and therefore, does not have revenues from operations. The Company's operating activities are dependent on the Company's working capital.

The Company's net loss for the year ended December 31, 2016 increased by \$278,994 when compared to the year ended December 31, 2015. The increase was mainly due to the no exploration and evaluation recovery recognized by the Company during the current year.

The Company's net loss for the year ended December 31, 2015 decreased by \$2,648,903 when compared to the year ended December 31, 2014. The decrease was mainly due to the following: (1) suspension of all exploration work and diamond drilling on the Pinaya Project coupled with the proceeds of \$630,000 from the closing of the Kaizen transaction which was recorded against exploration and evaluation expenditures; (2) there was no write-off of mineral properties during the year compared to \$910,231 in the prior year; and (3) there was no share-based compensation in the current year compared to \$217,441 in the prior year.

Rokmaster's total assets and total liabilities increased by \$139,141 and \$217,187, respectively, from December 31, 2015 to December 31, 2016. Total assets increased primarily from the closing of the first tranche in late December 2016 and offset by the sale of marketable securities held by the Company as at December 31, 2015 and total liabilities increased primarily as the Company continued to accrue and extend payment to its vendors, primarily to related parties.

Rokmaster's total assets and total liabilities increased by \$126,820 and \$351,663, respectively, from December 31, 2014 to December 31, 2015. Total assets increased primarily from the marketable securities held by the Company as at December 31, 2015 and total liabilities increased primarily as the Company continued to accrue and extend payment to its vendors, primarily to related parties.

Results of Operations

Rokmaster is an exploration stage company and its properties are in the early stages of exploration and none of the Company's properties are in production. Therefore, exploration and evaluation expenditures and administrative expenses relating to the operation of the Company's business are being expensed as incurred. Consequently, the Company's net loss is not a meaningful indicator of its performance or potential.

The key performance driver for the Company is the acquisition and development of prospective mineral properties. By acquiring and exploring projects of technical merit, the Company increases its chances of finding and developing an economic deposit.

At this time, the Company is not anticipating profit from operations in the near future. Until such time as the Company is able to realize profits from the production and marketing of commodities from its mineral interests, the Company will report an annual deficit and will rely on its ability to obtain equity or debt financing to fund on-going operations. Additional financing will be required for additional exploration and administration costs. Due to the inherent nature of the junior mineral exploration industry, the Company will have a continuous need to secure additional funds through the issuance of equity or debt in order to support its corporate and exploration activities.

For the nine months ended September 30, 2017 compared to the nine months ended September 30, 2016

The net loss for the nine months ended September 30, 2017 (the "Current Period") was \$887,738 compared to a net loss for the nine months ended September 30, 2016 (the "Comparative Period") of \$325,629. The increase in net loss of \$562,109 was primarily due to the following:

- (1) Consulting fees of \$204,992 during the Current Period compared to \$151,120 for the Comparative Period increased by \$53,872. The increase relates to evaluation of projects and assistance with corporate matters.
- (2) Corporate listing and filing fees of \$32,259 during the Current Period compared to \$15,763 for the Comparative Period. The increase of \$16,496 was primarily due to the following: the Company's listing in the OTC Pink Sheets and filing fees with respect to the shares for debt transaction.
- (3) Exploration and evaluation expenditures increased by \$53,167 to \$65,060 during the Current Period from \$11,893 in the Comparative Period when the Company did not have an active exploration project.
- (4) Share-based compensation of \$418,655 during the Current Period compared to \$nil in the Comparative Period. The Current Period's expense represents the fair value of the 9,050,000 stock options granted and vested during the Current Period. None were granted during the Comparative Period.
- (5) Travel, public and shareholder relations and conferences was \$112,603 during the Current Period compared to \$27,000 in the Comparative Period representing an increase of \$85,603. The Company increased its marketing efforts, including the engagement of an investor relations consultant, to promote the Company's Duncan Lake Project, its non-brokered private placement which closed on April 5, 2017 and the non-brokered private placement announced in July 2017 which did not close.

The Company recognized Other Expenses of \$12,429 during the Current Period compared to \$73,121 for the Comparative Period realizing a decrease of \$60,692 which was the result of the following: the Company did not have to sell its marketable securities as a result of closing its non-brokered private placement in April 2017 and the reduction of interest related to debts settled with shares in January 2017.

For the three months ended September 30, 2017 compared to the three months ended September 30, 2016

The net loss for the three months ended September 30, 2017 (the "Current Quarter") was \$223,637 compared to a net loss for the three months ended September 30, 2016 (the "Comparative Quarter") of \$100,455. The increase in net loss of \$123,182 was primarily due to the same factors mentioned in the Current Period and Comparative Period discussion above except for the corporate listing and filing fees expense.

Summary of Quarterly Results

The table below summarizes selected financial data, in Canadian dollars, of the Company for the three months ended September 30, 2017, and the previous seven quarters.

The Company's net loss increased by \$84,624 during the quarter ended September 30, 2017 compared to a net loss of \$139,013 for the second quarter of 2017 primarily due to the increase in consulting fees for reasons described in the Results of Operations above and recognition of \$37,115 in share-based compensation.

The Company's net loss for the three months ended June 30, 2017 decreased by \$386,075 when compared to the net loss for the three months ended March 31, 2017 which period realized an increase of \$352,839 when compared to the quarter ended December 31, 2016 primarily due to the recognition of shared-based compensation of \$381,500 during the quarter ended March 31, 2017 and for which none were granted during the quarters ended June 30, 2017 and December 31, 2016. The Company's total assets and its mineral interests also increased significantly by \$592,929 and \$625,000, respectively, when compared to the same prior quarter as a result of the acquisition of the Duncan Lake project.

The Company recognized a net income of \$439,949 during the quarter ended December 31, 2015 primarily due to the recognition of the \$630,000 recovery on exploration and evaluation as a result of the closing of the Kaizen transaction.

Liquidity and Capital Resources

As of September 30, 2017, the Company had \$69,614 in cash. The Company does not have any cash flow from operations due to the fact that it is an exploration stage company and therefore financings have been the sole source of funds.

At September 30, 2017, the Company had a working capital deficiency of \$323,703. The Company's current assets are not sufficient to support the Company's general administrative and corporate operating requirements on an ongoing basis for the foreseeable future. Accordingly, further financing will be required and the Company will have to raise additional funds to continue its operations.

Liquidity Outlook

The Company's cash position is highly dependent on its ability to raise cash through financings.

Based on the Company's financial position as at September 30, 2017, the Company will need to complete additional external financing either through equity, debt or other forms of financing. As other opportunities become available to the Company and subject to exploration work on the Company's project and results from such exploration program is determined, management may be required to complete additional financing.

This outlook is based on the Company's current financial position and is subject to change if opportunities become available based on exploration program results and/or external opportunities. At present, the Company's operations do not generate cash inflows and its financial success is dependent on management's ability to discover economically viable mineral deposits. The mineral exploration process can take many years and is subject to factors that are beyond the Company's control.

In order to finance the Company's future exploration programs and to cover administrative and overhead expenses, the Company will need to raise funds through equity sales, from the exercise of convertible securities, debt, deferral of payments to related parties, or other forms of raising capital. Many factors influence the Company's ability to raise funds, including the health of the resource market, the climate for mineral exploration investment, the Company's track record, and the experience and calibre of its management. Actual funding requirements may vary from those planned due to a number of factors, including the progress of exploration activities. Management believes it will be able to raise equity capital as required in the short and long term, but recognizes that there will be risks involved which may be beyond its control.

Going Concern

Rokmaster's consolidated financial statements have been prepared on the basis that the Company will continue as a going concern, which assumes that the Company will be able to meet its commitments, continue operations, and realize its assets and discharge its liabilities in the normal course of business for the foreseeable future. The Company has incurred losses since inception, has no recurring source of revenue, has an accumulated deficit of \$9,611,996 and a working capital deficiency of \$323,703 at September 30, 2017. These material uncertainties cast significant doubt upon the Company's ability to continue as a going concern.

The Company will need to raise sufficient funds as the Company's current assets are not sufficient to finance its operations and administrative expenses. The Company is evaluating financing options including, but not limited to, the issuance of additional equity and debt. The Company has no assurance that such financing will be available or be available on favourable terms. Factors that could affect the availability of financing include the Company's performance (as measured by numerous factors including the progress and results of its projects), the state of international debt and equity markets, investor perceptions and expectations and the global financial and metals markets. In addition to evaluating financing options, the Company implemented cost savings measures and deferred payments owed to related parties.

These consolidated financial statements do not reflect the adjustments to the carrying values of assets and liabilities and the reported expenses and statement of financial position classifications that would be necessary were the going concern assumption inappropriate, and these adjustments could be material.

Financial Instruments and Other Instruments

The Company classifies its cash, amounts receivable (excluding sales tax receivable) and reclamation bond as loans and receivables and marketable securities as available for sale financial assets. Accounts payable and accrued liabilities, loans from related parties and loan payable are classified as borrowings and other financial liabilities. As of September 30, 2017, the statement of financial position carrying amounts of these financial instruments closely approximate their fair values, except for accounts payable and accrued liabilities, loans from related parties and loan payable where the fair value may be less than carrying amounts due to liquidity risks.

The Company classifies financial instruments recognized at fair value in accordance with a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities.

Level 2 – Quoted prices in markets that are not active, or inputs that are observable, either directly or indirectly, for substantially the full term of the asset or liability; and

Level 3 – Prices or valuation techniques that require inputs that are both significant to the fair value measurement and unobservable (supported by little or no market activity).

Financial Risk Management

The Company's activities expose it to a variety of financial risks including credit risk, liquidity risk and market risk.

Credit Risk

Credit risk is the risk that one party to a financial instrument will fail to discharge an obligation and cause the other party to incur a financial loss. Financial instruments that potentially subject the Company to credit risk consist of cash, short-term investment, reclamation bonds and amounts receivable. The carrying amount of financial assets recorded in the consolidated financial statements, net of any allowances for losses, represents the maximum exposure to credit risk.

The Company deposits its cash and short-term investment with a high credit quality major Canadian financial institution as determined by ratings agencies. The Company does not invest in asset-backed deposits or investments and does not expect any credit losses. To reduce credit risk, the Company regularly reviews the collectability of its amounts receivable and establishes an allowance based on its best estimate of potentially uncollectible amounts. The Company historically has not had difficulty collecting its amounts receivable.

Liquidity Risk

Liquidity risk is the risk that an entity will encounter difficulty in raising funds to meet commitments associated with financial instruments. The Company attempts to manage liquidity risk by maintaining a sufficient cash balance. As at September 30, 2017, the Company had cash of \$69,614 to settle current liabilities of \$552,750. Further information relating to liquidity risk is disclosed in the "Liquidity Outlook" section of this MD&A.

Market Risks

The significant market risks to which the Company is exposed are currency and interest rate risks.

The operating results and financial position of the Company are reported in Canadian dollars. As the Company conducts exploration and property examinations in other countries outside of Canada, some of the Company's transactions are denominated in currencies other than the Canadian dollar. The results of the Company's operations are subject to currency transaction and translation risks. The Company has not entered into any agreements or purchased any foreign currency hedging arrangements to hedge possible currency risks at this time. Management believes the foreign exchange risk derived from currency conversions for property examinations incurred in other countries outside of Canada is not significant and therefore does not hedge its foreign exchange risk.

Interest rate risk is the risk that the future cash flows of a financial instrument will fluctuate due to changes in market interest rates. The Company's interest rate risk arises primarily from interest earned on the short-term investment. Cash is not subject to interest rate risk since it does not bear interest.

Capital Management

The Company primarily considers shareholders' equity in the management of its capital. The Company manages its capital structure and makes adjustments to it based on funds available to the Company, in order to support exploration and development of mineral properties. The Board of Directors has not established quantitative capital structure criteria management, but will review on a regular basis the capital structure of the Company to ensure its appropriateness to the stage of development of the business.

The Company's objectives when managing capital are:

- To maintain and safeguard its accumulated capital in order to provide an adequate return to shareholders by maintaining sufficient level of funds, to support continued evaluation and maintenance of the Company's existing properties, and to acquire, explore and develop other precious metals, base metals and industrial mineral deposits;
- To invest cash on hand in highly liquid and highly rated financial instruments with high credit quality issuers, thereby minimizing the risk and loss of principal; and
- To obtain the necessary financing if and when it is required.

The properties in which the Company currently holds an interest in are in the exploration stage and the Company is dependent on external financing to fund its activities. In order to carry out planned exploration and development and pay for administrative costs, the Company will spend its existing working capital and attempt to raise additional amounts as needed.

Management reviews its capital management approach on an ongoing basis and believes that this approach, given the relative size of the Company, is reasonable. In order to facilitate the management of capital and development of its mineral properties, the Company's management informs the Board of Directors as to the quantum of expenditures for review and approval prior to commencement of work. In addition, the Company may issue new equity, incur additional debt, enter into joint venture agreements or dispose of certain assets. When applicable, the Company's investment policy is to hold cash in interest bearing accounts at high credit quality financial institutions to maximize liquidity. In order to maximize ongoing development efforts, the Company does not pay dividends. The Company expects to continue to raise funds, from time to time, to continue meeting its capital management objectives.

There were no changes in the Company's approach to capital management during the nine months ended September 30, 2017 compared to the year ended to December 31, 2016. The Company is not subject to externally imposed capital requirements.

Recent Developments and Outlook

The Company expects to obtain financing in the future primarily through further equity and debt financing. There can be no assurance that the Company will succeed in obtaining additional financing, now or in the future. Failure to raise additional financing on a timely basis could cause the Company to suspend its operations and eventually to forfeit or sell its interest in its resource properties.

The Company's management has evaluated the effectiveness of the design and operation of the Company's internal control over financial reporting as of the period covered by this report. Based on the result of the assessment, the Company's Chief Executive Officer and Chief Financial Officer have concluded that the Company's internal controls over financial reporting are effective.

Disclosure Controls and Procedures Disclosure controls and procedures are designed to provide reasonable assurance that material information is gathered and reported to senior management, including the Chief Executive Officer and Chief Financial Officer, as appropriate in order to permit timely decisions regarding public disclosure.

Management, including the Chief Executive Officer and Chief Financial Officer, has evaluated the effectiveness of the design and operation of the Company's disclosure controls and procedures. Based on this evaluation, the Chief Executive Officer and Chief Financial Officer have concluded that the Company's disclosure controls and procedures, as defined in National Instrument 52-109 – *Certification of Disclosure in Issuer's Annual and Interim Filings*, are effective to ensure that information required to be disclosed in reports that are filed or submitted under Canadian securities legislation are recorded, processed, summarized and reported within the time period specified in those rules.

Corporate Governance

<u>Composition of the Board of Directors</u> The Board of Directors of Rokmaster is at present comprised of five directors, three of whom are considered to be independent.
